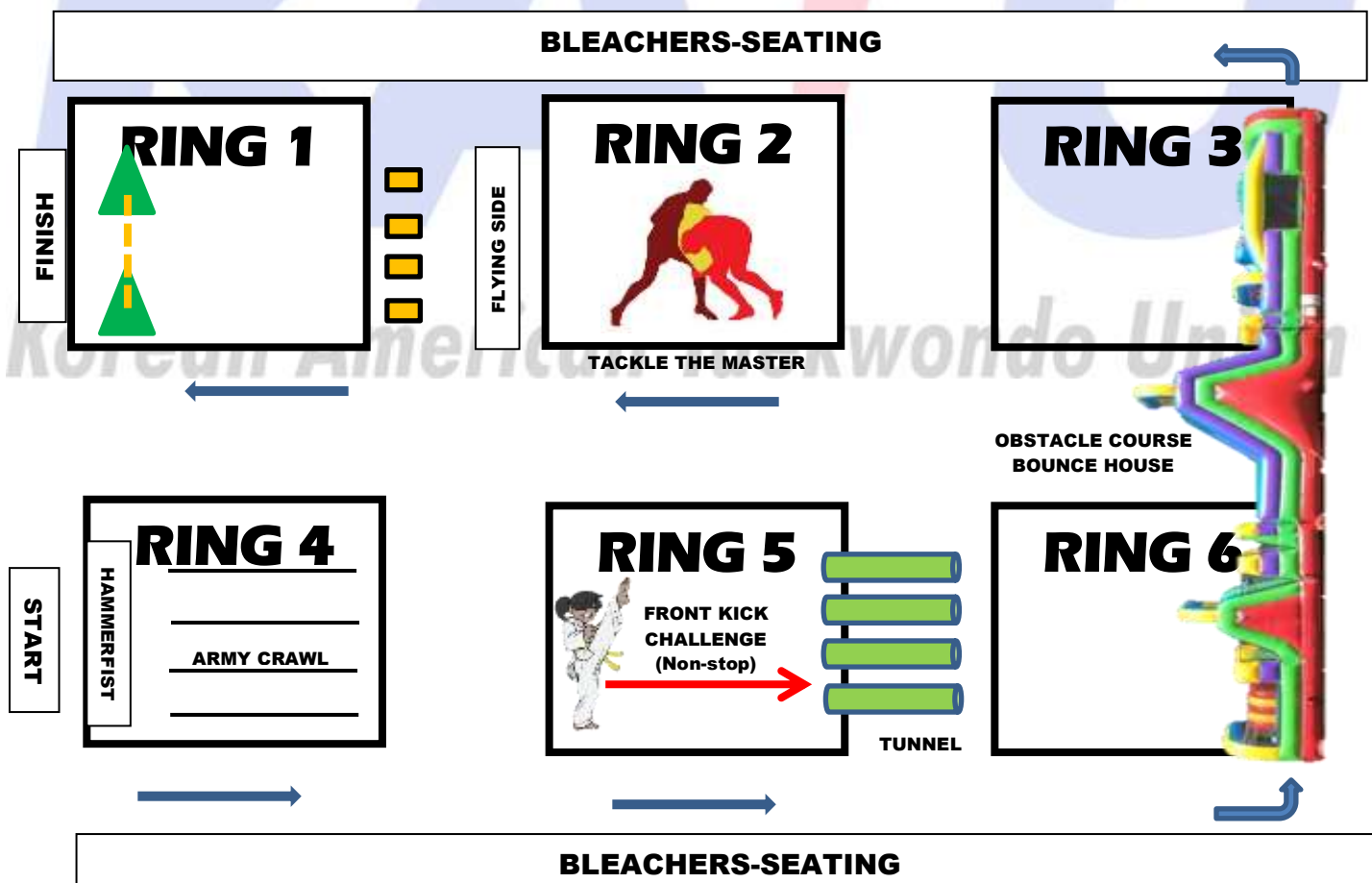
- A. Eligibility: Young Tigers Ages 3-6
- B. Directed by Master Instructors on the competition floor. Spirit participants will be competing in a relay style and will be divided into groups based on age.
- C. Young Tigers will not be picked up but will be aided if needed for Balance Beam.
- D. Order of Relay:

START

- 1. Hammer fist
- 2. Army Crawl
- 3. Front Kick Challenge (Non-Stop)
- 4. Tunnel
- 5. Obstacle Bounce House
- 6. Tackle the Master
- 7. Flying Side Kick

Regular Division

1. Board Breaking

- A. Point System: 1st, 2nd, 3rd, 3rd
- B. Eligibility: All Belts
 - 1. Spirit Division
 - a. Ages 3-4
 - b. Ages 5-6
 - 2. Color Belt Division
 - 3. Black Belt Division
- C. Competitor can choose the kind of techniques for allotted amount of boards.
- D. The Tournament Committee will provide (2) Boards for Spirit, (3) Boards for Color Belts, and (4) Boards for Black Belts. Purchase of boards will be completed at individual locations. Cost: \$3/board. Payment can be made by CASH only.
- E. The maximum set up time to include the maximum performance time is 2 minutes.
- F. The maximum number of tries is 2 times.
- G. The performance must be done within the official Tournament Ring Size.
- H. All boards for breaking will be the standard demonstration board sizing.
- I. Referees and Judges **are not** allowed to hold boards. All Masters will be holding for Spirit Division.

Judging Criteria for Board Breaking

- A. Difficulty: Difficulty of technique will be based on the following order of superiority (in ascending order)
 - 1. Hand Technique
 - 2. Standing Kick Technique
 - 3. Kicking Technique with Spinning Motion
 - 4. Jump Kick Technique
 - 5. Jump Kick Technique with Spinning Motion
 - 6. Multiple Breaking Technique
 - 7. Multiple Spinning Jump Technique
 - 8. Flying Kick Technique
 - 9. Flying Kick Technique with Spinning Motion
- B. Difficulty of Breaking will be based on the number of boards.
 - 1. Number of boards held at one time.
 - 2. Total number of boards in the performance. (Unlimited within time limit)
- C. Technique will be judged based on Accuracy, Speed, Power, and Presentation
 - 1. Accuracy: breaking at the first attempt is superior to breaking at the second attempt, and breaking at the center is superior to chipping the board.
 - 2. Speed: suspended holding is superior to fixed holding, and the competitor who executes more techniques with less time is superior to a competitor who executes fewer techniques in a longer time.
 - 3. Power: higher number of boards broken is superior to the lower number of boards broken.
 - 4. Presentation: balance, rhythm, manners, and kihap from entrance to completion.

Color Belts	3	Any 1 Hand + Any 1 Kick + Freestyle
Black Belts	4	Any 1 Hand + Any 1 Kick + (2) Freestyle

2. Poomsae (Forms)

- A. Point System: 1st, 2nd, 3rd, 3rd
- B. Competitors will be judged on ability to perform the form associated with their current rank, balance, rhythm, and manner. Competitors may choose to perform their previous level if they were recently promoted in Belt Ranking.
- C. White & High White Belts will also perform Breaking Techniques. White Belts will perform Front Kick and High White Belt will perform Roundhouse Kick in addition to their Poomsae.

3. Sparring (Color Belt)

- A. Format
 - 1. Random Seeding
 - 2. Single Elimination
 - 3. No Head Contact
 - 4. Grooming Needs
 - Finger nails and Toes Nails must be trimmed short
 - 5. No Glasses to be worn
 - Sports Glasses allowed only with Face Shield Protector
- B. Points
 - 1. 1 Point-Valid punch or kick on chest protector
 - 2. 2 Points-Valid turning kick on chest protector
- C. Application of Head Contact Safety Rules
 - 1. NO HEAD CONTACT- ALL Color Belts of any age
 - 2. Contact to head accidentally, deduct half-point. Contact to head intentionally, deduct 1 point.
- D. Safety Gear Requirements

- Face Shield Protector OR
- Mouth Piece

4. Grooming Needs

Finger nails and Toes Nails must be trimmed short

5. No Glasses to be worn

Sports Glasses allowed only with Face Shield Protector

B. Points to Body

1. 1 Point-Valid punch or kick on chest protector
2. 2 Points-Valid turning kick on chest protector
3. 1 Point awarded for every one Gam-jeom given to the opponent contestant
4. At the end of the second round, 12 point difference rule will be in effect for Black Belts only.

C. Points to Head

1. 3 Points-Valid kick to the head
2. 4 Points-Valid turning kick to the head
3. 1 Point awarded for every one Gam-jeom given to the opponent contestant
4. At the end of the second round, 12 point difference rule will be in effect for Black Belts only.

D. Safety Gear Requirements

Sparring competitors must provide their own safety/sparring equipment: head gear, chest protector, forearm guards, groin protector, shin and instep protector, mouthguard and/or face shield protector.
